As determined by [Public Places and Local Government Property Local Law 2016 – Part 3.3](#) - Consuming alcohol on Shire Property requires a Permit and possibly also a Liquor Licence, depending on the function or event. If alcohol is to be served at an event, an authorised “Application for Permit to Serve Alcohol on Shire Property” is required if alcohol is to be either consumed, served or sold on Shire property. If alcohol is to be sold at your event or function, then approval from the Shire and an Occasional Licence from the Department of Local Government, Sport and Cultural Industries will be required – please allow at least fourteen (14) days before your event to obtain this.

About selling alcohol at your event: If you intend to sell alcohol, it is your responsibility to obtain the appropriate licence for your event, and retain a copy of the Approved Licence together with this application (once approved). Contact the Narrogin Courthouse or go online to [Department of Local Government Sport and Cultural Industries – Racing, Gaming and Liquor](#) for more information.

Important: Once authorised by the CEO Shire of Narrogin – This document serves as your Permit to Service Alcohol on Shire Property, please retain and take to your event.
