6.3. COVID 19 Updates

Sara Pellant – Narrogin Health Service

- Mandatory vaccination for all health staff
- Aged care facilities vaccinated
- There are ongoing staff shortages
- COVID testing is ongoing

Joanne Spadaccini – Department of Communities

- Recently Narrogin Regional Leisure Centre received 2 COVID kits. The kits contain full PPE (mask, gown, goggles etc) as well as mask to issue, 20 sets of bedding (air mattresses, blankets, sheets, towels etc)
- The next step is to train staff on the procedures for opening up in the case of an emergency.

Simon Vogel – DFES – Narrogin Regional Officer

• From 1 December all DFES staff must have had at least their first COVID vaccine.

Snr Sgt John Bouwman – WA Police

• It is important that we have an exercise soon, this can be a desktop exercise. It was suggested that this occur in the morning and be followed by lunch.

ESO provided details of an update provided by Ronan Blaney

Ronan Blaney – Narrogin St John Ambulance

- As of Sunday 19 September the sub centre has transitioned to a career/volunteer hybrid depot. This means that Narrogin Depot will now be manned by a Paramedic and a volunteer officer from 7.00 am to 7.00 pm, 7 days a week. Outside these hours 2 x ambulance volunteer officers will be attending calls in the community.
- New ambulance commissioned Mercedes Mk7 with Stryker Stretcher in use as of 19 September.
- PPE stores well stocked in the event of COVID19 incident.
- Currently recruited 9 new volunteers in the past 6 months, increasing our volunteer base by 25%.
