3. CONFIRMATION OF MINUTES OF PREVIOUS MEETING OF THE TOWNSCAPE ADVISORY COMMITTEE

There are no items presented by Administration that require decisions by the Committee.

5. MATTERS FOR DISCUSSION / INFORMATION

5.1. CURRENT BUDGET PUBLIC ART STRATEGY – COUNCIL RESOLUTION

The following recommendation to Council was made by the TAC, at its 9 May meeting:

"The Townscape Advisory Committee (TAC) recommends to Council, that the \$25,000 (IO113) in the 2022/23 Budget, allocated to Councils Public Art Strategy Implementation, be expended as follows:

- 1. A mural by artist Georgina Patterson, at a cost of \$(TBA by MCLC) inclusive of a protective coating, installed on the Telstra Building facing Fortune Street;
- 2. No artwork can proceed until such time that an amical agreement is reached between the Shire of Narrogin and Telstra to the satisfaction of the Shire's Chief Executive Officer, for the application of the artwork and the ongoing maintenance and liability etc;
- 3. The mural is "NARROGIN" as per the concept presented to the TAC but with the "LOVE the LIFE" font from the alternative concept presented;
- 4. The surplus funds of \$(TBA by MCLC) left from this mural to be transferred to the Tourism and Area Promotion Reserve, towards the next large public art project i.e. Good Shed Mural:
- 5. That \$25,000 be included in the 2023/24 Annual Budget for expenditure on Councils Public Art Strategy."

The above recommendation was presented to Council at its Ordinary Meeting 24 May 2023 with Council resolving as follows:

"That with respect to the Council's allocation of public art for the 2022/2023 Council:

- 1. Approve the balance in the Shire's Annual Budget of \$25,000, to be transferred to the Tourism & Area Promotion Reserve, as an allocation to a future large mural installation, such as on the Goods Shed wall.
- 2. Request the Administration to include \$25,000 in the 2023/24 Draft Annual Budget, for expenditure on the continuing implementation of the Shire's Public Art Strategy.
- 3. Request the Chief Executive Officer to liaise with Telstra Corporation regarding proposals for an iconic artwork on the southern and eastern walls of their premise in Fortune and Rowley Streets."

The Committee noted the council resolution.

5.2. ARTS NARROGIN MURAL REQUEST

Attachment 1 Letter from Arts Narrogin.
Attachment 2 Concept drawings for the Mural.

The attached letter from Arts Narrogin was received by Administration, requesting permission from the Shires Chief Executive Officer (CEO), to apply a mural to their current premises on the corner of Park and Fairway Streets (the former DCVC) Eastern facing wall.

The Shire's CEO, in response to Arts Narrogin, advised that as the delegated building owner, he had no problem with Arts Narrogin designing and applying a mural using local artists however out of courtesy and respect thought it prudent that the TAC be advised of the offer of a mural by Arts Narrogin.

Arts Narrogin Chairperson Barbara Fletcher has offered to be in attendance to the TAC meeting on 6 June to discuss the proposal and design with the TAC. If through this discussion the TAC has no objection to the proposal and design then it would be envisaged that Arts Narrogin would proceed, however if the TAC did have an objection with the proposal or design then the TAC would then need to make a recommendation to the Council.

Cr J Pomykala (as an Arts Narrogin board member) presented the concept designs for the mural on their building.






Basic Concept for Arts Narrogin Mural - Eastern Wall.
